"14(2)(g) Two International Players [One Male and One Female] from amongst those of its members who hail form the jurisdiction of MCA. The said players to be nominated to the Apex Council shall be the representative of all the Intl players from Maharashtra and elected amongst themselves," (from Constitution as approved and displayed on the BCCI website)

During Scrutiny and on mail their were Objection on two aspect that,

- A) International Players are to be nominated and not elected.
- B) The amendment proposed in trail mail dated 18 September says, deletion of above Rule 14(2)(g) and to be amended as below,

Dear Sirs,

This email is in reference to your email dated 16th September 2019 to the CEO, BCCI, enclosing the revised constitution ("REVISED CONSTITUTION") of Maharashtra Cricket Association ("MCA").

The Committee of Administrators has been informed that there is some confusion surrounding interpretation of Rule 14(2) of the Revised Constitution amongst the members of the MCA, and additionally Rule 14(2)(g) of Revised Constitution contains an inadvertent error. In view of the aforesaid, please see set out below proposed amendments to be incorporated in the Revised Constitution of MCA:

REVISED CONSTITUTION

PROPOSED AMENDMENT

RULE 14(1)

There shall be an Apex Council for the MCA which shall be primarily responsible for the governance of the affairs of the MCA.

RULE 14(1)

There shall be an Apex Council for the MCA which shall be primarily responsible for the governance of the affairs of the MCA. \_THE ELECTED COUNCILLORS OF THE MCA SHALL BE ELECTED BY THE FULL-MEMBERS OF THE MCA AT THE ANNUAL GENERAL MEETING. THE ELECTION OF THE ELECTED COUNCILLOR SHALL TAKE PLACE AFTER THE ELECTION OF THE OFFICE BEARERS IN TERMS OF RULE 6.\_

RULE 14(2)

\_THE APEX COUNCIL SHALL COMPRISE OF THE FOLLOWING 19 COUNCILLORS (INCLUDING 5 ELECTED OFFICE BEARERS AS PER RULE 6)\_:

- (a) Ten to be elected amongst the 21 District Cricket Associations on a Zonal basis. (Two from each of the five Zones),
- (b) Two to be elected from and amongst the Life Members, Patrons, Benefactors and Former International Cricketers of MCA,
- (c) Two to be elected from and amongst the Affiliated Club Members of MCA,
- (d) One to be elected from and amongst the four Founder Gymkhanas and the Special Gymkhana,
- (e) One to be elected from and amongst the Institution Members (Colleges),
- (g) Two \_INTERNATIONAL\_ Players [One Male and One Female] from amongst those of its members who hail form the jurisdiction of MCA. \_THE SAID PLAYERS TO BE NOMINATED TO THE APEX COUNCIL SHALL BE THE REPRESENTATIVE OF ALL THE INTL PLAYERS FROM MAHARASHTRA AND ELECTED AMONGST THEMSELVES\_.

(h) One to be nominated by the Accountant General of Maharashtra from among the serving senior functionaries of the office, co-terminus with the nominee's tenure;

RULE 14(2)

\_THE COMPOSITION OF APEX COUNCIL SHALL NOT EXCEED 19 COUNCILLORS, OUT OF WHICH 5 SHALL BE ELECTED OFFICE BEARERS AS PER RULE 6 AND 3 SHALL BE NOMINATED COUNCILLORS AS PER RULE 14(2)(G) AND 14(2)(H), AND THE REMAINING 11 ELECTED COUNCILLORS MAY BE ELECTED BY THE FULL MEMBERS SUBJECT TO THE CAP SPECIFIED FOR EACH CATEGORIES SET OUT BELOW IN (A) TO (E)\_:

- (a) Ten to be elected \_FROM AND\_ amongst the 21 District Cricket Associations on a Zonal basis. (Two from each of the five Zones),
- (b) Two to be elected from and amongst the Life Members, Patrons, Benefactors and Former International Cricketers\_ of MCA,
- (c) Two to be elected from and amongst the Affiliated Club Members of MCA,
- (d) One to be elected from and amongst the four Founder Gymkhanas and the Special Gymkhana,
- (e) One to be elected from and amongst the Institution Members (Colleges),
- (g) Two Players [One Male and One Female] \_NOMINATED BY THE CRICKET PLAYERS ASSOCIATION\_ from amongst those of its members who hail from the jurisdiction of MCA.
- (h) One to be nominated by the Accountant General of Maharashtra from among the serving senior functionaries of the office, co-terminus with the nominee's tenure;

Vide the aforesaid proposed amendments, the Committee of Administrators \_inter alia\_ seeks to clarify that Rule 14(2) of the attached constitution in no manner restricts the electoral college for electing the Councillors in the Apex Council, and all Full Members have the right to vote for electing each of the elected Councillors, irrespective of the category that the Full Member belongs to. Further, please note that the stipulations under Rule 14(2)(a) to 14(2)(e) only provides that the candidates for election to the reserved category of Councillors posts shall belong to the respective category, and the elected Councillors will then be elected from amongst these candidates by all the Full Members at the General Meeting.

In order to expedite the process of registration, the said changes have also been incorporated, in track, in the attached word document.

MCA is hereby requested to incorporate the aforesaid proposed amendments in a complete and accurate manner and submit a copy of the registered constitution to the Committee of Administrators at the earliest, in order to be in compliance with the judgment dated 9th August 2018 passed by the Hon'ble Supreme Court.

MCA is hereby also requested to conduct its elections in accordance with the directions dated 6th September 2019 issued by the Committee of Administrators, failing which MCA will become ineligible to participate in BCCI election process.
