1.	Invitation	Quotations in sealed envelope are invited for the proposed installation of Turnstile System at MCA International Stadium, Pune. Bidders who have submitted bid in response to tender dated 16/08/2023 have the option to re-submit their quotation. If not re-submitted, originally submitted tender shall be considered.
2.	Eligibility of Bidder	<ul style="list-style-type: none"> <li>• Bidder/Partner in its individual capacity should be a manufacturer of turnstile having its own software and server support.</li> <li>• Profit making Entity with own/partnered annual turnover of 10 Cr. in last 3 years.</li> </ul>
3.	Earnest Money Deposit	Rs. 10,00,000/- by Demand Draft (DD) in favor of “MAHARASHTRA CRICKET ASSOCIATION” payable at Pune along with submission of Quotation. The DD should be drawn on a scheduled bank and should be put into a separate sealed envelope with the name of work and name of the bidder clearly written on it. This DD should be submitted alongwith Quotation in separate sealed envelope.
5.	Security Deposit	Earnest Money Deposit shall be converted as Security Deposit.
6.	Performance Bank Guarantee	On successful handover of the project the security deposit will be converted and treated as performance bank guarantee. Validity shall be till Defect Liability Period.
7.	Commencement of work	Immediately from the date of issuance of work order.
8.	Time frame	The time frame for the completion of work shall be 30 days from the date of issuance of work order.

Bill and Final Bill.</li> <li>• All incoming and outgoing materials including empty containers and bags challans will have to be signed by duly authorized MCA manager/Supervisor and entered into register which shall be in the custody of MCA.</li> <li>• Final bill shall be paid within 10 days from its date of certification by MCA technician.</li> <li>• After issuing of LOI, successful bidder shall submit billing breakup for approval by MCA.</li> </ul>
