Rules and Regulations as per BCCI Guidelines

1. It will be the responsibility of the contractor to take all statutory permission/ licenses from the authorities and comply with all their terms and conditions, failing which you will be solely liable for non-compliance of the conditions laid down by the authority
2. You shall be allotted 52 stalls in the stadium for the said match
3. You will have to submit the price list of each item to the Association in advance for approval. In case of amendments to the rates, the association will discuss the same.
4. You will have to display the price list of the items to be sold on each stall as approved by Maharashtra Cricket Association
5. You will follow directives for Health and Fire Safety in case of the use of cylinders in stadium premises as directed by the Maharashtra Cricket Association
6. Food Materials served to the spectators should be of standard quality and the presenting party should comply with all the necessary FSSAI guidelines
7. Vendors are required to comply with the Legal Metrology Act 2009 and also the Legal Metrology (Packaged Commodities) Rules 2011. In case it is found that said rules are contravened, then the contract will be immediately terminated and the vendor will be blacklisted or any of its affiliated units
8. No director/partner/employee shall be directly or indirectly connected with the Association
9. Maharashtra Cricket Association reserves the right to accept or reject the offer without assigning any reason
10. This agreement and any matter relating thereto shall be subject only to the jurisdiction of Courts at Pune
