Expression of Interest for the post of Director of Cricket at MCA Academy

Background:

Maharashtra Cricket Association (MCA) is committed to align its cricket development infrastructure with the highest standards set by the Board of Control for Cricket in India (BCCI). In line with BCCI's operational and coaching structure guidelines, the MCA proposes the appointment of an **Director of Cricket** for its academy to oversee its technical, developmental, and administrative functions.

Objective of the Appointment:

To ensure a structured, long-term vision for talent identification and nurturing, the Academy Director will play a key leadership role in aligning MCA's coaching ecosystem with the BCCI's National Cricket Academy (NCA) standards and guidelines.

Eligibility Criteria for Academy Director:

- 1) Cricket playing Experience – Minimum 50 First-Class Games or NCA Level 2 or Level 3 Coaching Certificate.
- 2) Education Qualification – Graduation Degree
- 3) Management & Administrative Skills – Administrative/Similar role Experience of 10 years.
- 4) Other criteria – Excellent communication skills and Fluency in particular local language.

Necessary documentary evidences regarding the eligibility to be submitted along with the application.

Roles & Responsibilities:

The Academy Director will be responsible for:

- Formulating and supervising all coaching, technical, and fitness programs across age groups.
- Structuring yearly training calendars in sync with BCCI's NCA framework.
- Supervising the coaching and support staff, and implementing evaluation mechanisms.
- Talent identification and promotion through regular scouting camps.
- Organizing coach education and certification programs under BCCI guidelines.
- Coordinating with state selectors and team coaches to monitor player development.
- Ensuring scientific use of infrastructure, sports technology, and performance analytics.
- Acting as the key liaison with the BCCI/NCA for all academy-related directives and programs.
