### **1. Invitation:**

Maharashtra Cricket Association (MCA) invites Quotations in sealed envelope for development of full-size cricket ground. Details of the work are enclosed herewith.

### **2. Earnest Money Deposit:**

Rs. 1,00,000/- by Demand Draft (DD) /Cheque in favour of "MAHARASHTRA CRICKET ASSOCIATION" payable at Pune along with submission of Quotation. The DD/Cheque should be put into a separate sealed envelope with the name of bidder clearly written on it.

### **3. Security Deposit:**

5% of Tender Value. Earnest Money Deposit shall be adjusted as Security Deposit. The security deposit will be held by MCA till the end of Defect Liability period.

### **4. Eligibility of Bidder:**

The bidder should have completed infrastructure work of similar scale (work order/invoice should be submitted) in one of the last 3 Financial Year. The bidder should be Profit making Entity with an annual turnover of 30 Lakhs or above in Financial Year 2023-2024 (Audited Balance sheet should be enclosed).

### **5. Timelines for Work Completion:**

The time limit for the completion of work shall be 90 days from the date of issuance of LOI/Work Order.
