INVITATION TO BID FOR TEAM PARTICIPATION RIGHTS IN WMPL FOR 3 SEASONS

1. Introduction

Maharashtra Cricket Association (MHCA) invites bids from reputed entities for acquiring **Team Participation Rights in Women's Maharashtra Premier League (WMPL) for 3 seasons (2025-2027)**. The selected bidder will be granted exclusive rights to own and operate a franchise team for three seasons (2025-2027) of WMPL.

2. Eligibility Criteria (Technical Requirements)

Bidders must satisfy the following:

- Registered Indian company / LLP / Partnership / Sole Proprietorship.
- Audited Financial turnover should be 250 crores or above as on 31/03/2025. Consortium turnover amongst 2 or more entities is not allowed.
- Not blacklisted or debarred by any government or sports body.
- PAN and GST registration mandatory.

Documents to be Submitted:

- Company Profile with legal structure.
- Audited financial statements for last 3 Financial years.
- Net worth certificates from CA.
- PAN and GST details.
- Declaration of no pending litigation or disqualification
- All above documents should be enclosed and sealed in Technical Bid envelope.

3. Financial Proposal Requirements

- Bidders shall submit a **sealed Financial Bid** quoting the **franchise fee** (exclusive of taxes) for WMPL Seasons 2025-2027.
- Base Price: ₹ 3,40,00,000/- for three seasons 2025-2027 (exclusive GST and other taxes applicable if any).
- Payment Schedule and Terms will be defined in the Franchise Agreement.

- Financial Bid Amount (Annexure A) – Team Participation Fee on Bidders Letter Head sealed and duly signed by Authorized person.
- Signed Declaration on Bidders Letter Head sealed and duly signed by Authorized person that bid amount shall be deposited or transferred to MHCA within 3 days of Team allotment or confirmation from MHCA.

4. Bid Submission Process:

- EMD (Earnest Money Deposit) – DD of INR 1 Crores in the name of Maharashtra Cricket Association. The EMD shall be adjusted in the Franchisee fees amount of Successful bidder.
- Bidders must submit two sealed envelopes:
Envelope A – Technical Bid
Envelope B – Financial Bid
Envelope C – EMD
- All 3 envelopes to be placed in a larger sealed envelope marked:
“Bid for WMPL – Team Participation Rights”
