TENDER NOTICE FOR SALE OF SCRAP MATERIALS

Maharashtra Cricket Association (MCA) invites quotations in sealed envelopes from eligible and reputed contractors/agencies/firms for the **sale and disposal of scrap materials** located at **MCA International Stadium, Gahunje, Pune and Cadence Cricket Academy, Mundhwa.**

1. Scope of Work

The selected bidder shall be responsible for:

- Collection, segregation, loading, transportation, and disposal of scrap materials (such as metal, plastic, wood, electrical waste, used equipment, and miscellaneous non-hazardous materials) as available at designated MCA premises.
- Safe handling and adherence to environmental and safety regulations.
- Clearing the site post removal and restoring it to a clean and acceptable condition.

2. Site Visit and Inspection (Mandatory)

All interested bidders are required to inspect the scrap materials physically at the MCA International Stadium, Gahunje and Cadence Cricket Academy, Mundhwa before submitting their bids.

Locations - MCA Stadium, Gahunje and Cadence Cricket Academy, Mundhwa, during working hours from Monday to Wednesday – 28th to 30th July 2025. Site visit must be coordinated with MCA Operations Department –

3. Eligibility Criteria

- a. The bidder must be an Indian entity (Individual/Firm/Company) registered for carrying out scrap purchase or disposal.
- b. Must possess a valid **GST registration** and **PAN card**.
- c. Must have experience in scrap collection, resale, or disposal in at least **2 similar contracts** in the past 3 years.

- d. Must not have been blacklisted by any government, semi-government, or private organization.
- e. Must submit a refundable **Earnest Money Deposit (EMD)** of ₹25,000/- via DD or NEFT (refundable for non-selected bidders).

4. Documents to be Submitted

- Signed and sealed quotation along with letter of acceptance for all terms & conditions.
- Copy of PAN, GST certificate, and business registration.
- Experience/work orders or completion certificates of similar scrap handling assignments.
- Quotation per metric tonne/kilogram/item.
- EMD.
- Undertaking of non-blacklisting and compliance with all applicable laws.

5. Evaluation Criteria

- **Highest quote/value** per scrap category/item (H1 basis).

6. Important Dates

- **Site Visit Window:** 28th to 30th July 2025 (Monday to Wednesday)
- **Last Date of Submission:** 31st July, Thursday by 4PM at MCA Head Office, Shivajinagar.

7. Terms & Conditions

- 100% advance of ascertained amount to be paid to MCA before lifting all scrap.
- The quantity and type of scrap will be estimated but final billing will be done based on actual quantity.
- Selected bidder must clear and lift all scrap within **7 working days** from award of contract.
- Transportation, labour, safety, and any local permissions and cost thereon shall be the responsibility of the bidder.
- MCA reserves the right to reject any or all bids without assigning any reason.
- In case of default, MCA may forfeit EMD and award contract to the next highest bidder.
